



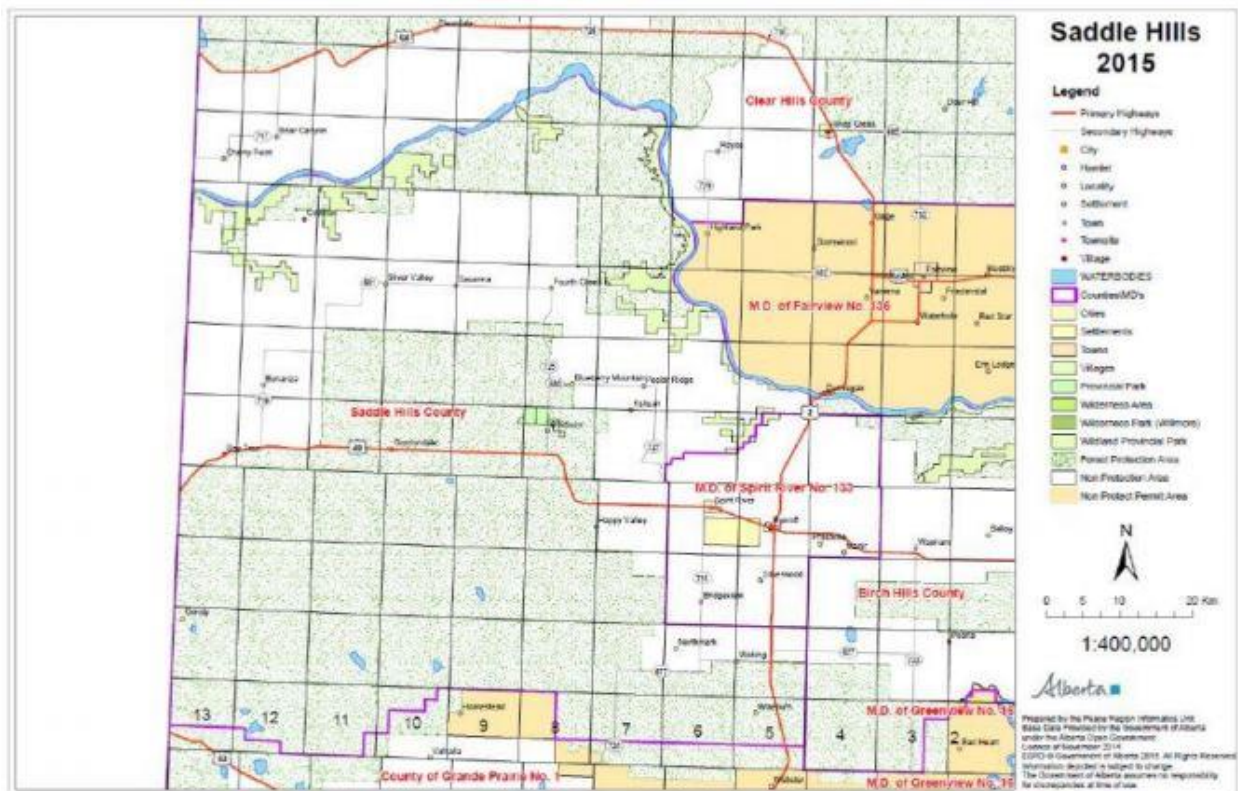
## Fireworks Permits

Consumer Fireworks Permits are required in all areas of Saddle Hills County and in the Forest Protection Area (FPA) during fire season from March 1 to October 31. Fireworks permits are required from Alberta Agriculture & Forestry at (780) 538-5560.

For winter Fireworks in the FPA please print off and fill out the Fireworks Permit Application below. You may submit it in person at the County Complex [Junction of Highway 49 and Highway 725]; by mail [RR 1, Spirit River, Alberta, Canada, T0H 3G0]; by fax [780-864-3904] or via email to [protectiveservices@saddlehills.ab.ca](mailto:protectiveservices@saddlehills.ab.ca).

Outside of the Forest Protection Area (FPA), permits are available from Saddle Hills County. Fireworks Permits are required by federal and provincial regulations.

5. Should the Fire Officer or designate order a halt to the display for safety reasons, I will immediately comply.
6. I will be responsible for costs of fire suppression or damages to property resulting from the possession or discharge of fireworks under this permit.
7. I have read and agree to abide by the disclaimer on the purchase portion of this permit.
