REMINDER: DITCHING PERMITS REQUIRED

A friendly reminder that permits are required for any work carried out in County ditches and Rights-of-Way. It is the responsibility of the landowner to contact the County prior to any proposed work. Thank you for your cooperation.

ROAD CONSTRUCTION - TOWNSHIP ROAD 810 (DOE RIVER)

Saddle Hills County is completing slide repairs on Township Road 810 by the Doe River. There will be traffic delays while equipment is present. We ask that all vehicles please drive slowly through the construction zone. Thank you for your cooperation.

DRIVEWAY SNOWPLOW AGREEMENTS

Driveway Snowplow Agreements for seniors and the public are now available for the 2023/24 season. To ensure that you are on the snowplow list, please fill out an application online or at the County office. Driveway snowplowing is free if you are disabled or a senior, otherwise fees apply.

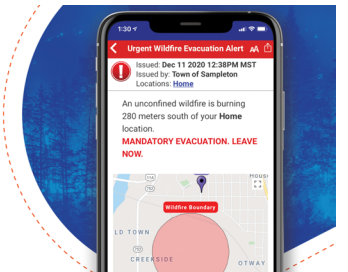
SCHEDULED OFFICE CLOSURE - NOV. 13
