## REMINDER: DITCHING PERMITS REQUIRED

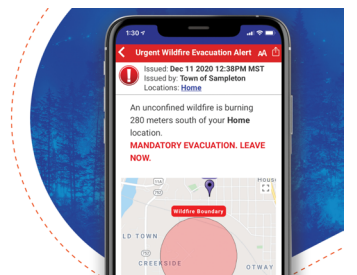


## WATERLINE CONSTRUCTION IN EAST WOKING
