SAFETY TIPS FOR PASSING PLOWS & GRADERS

Please be aware of slow moving graders and snowplows. Our graders and plows use highways to get around the County to ensure all of our roads remain safe and clean.

- Treat graders and plows as slow moving vehicles and only pass when it is safe to.
- Watch for signal lights while on the highway.
- When graders and plows are working please stay further back and only pass when it is safe, or when the operator signals for you to do so.
- Allow graders and plows extra room at intersections as they may be backing up or turning around.
- Stay behind any dust or snow clouds so that oncoming traffic and grader and plow operators can see your vehicle clearly.

RESIDENTIAL SECURITY SYSTEM GRANT

Saddle Hills County is offering a \$500 grant to County residents to help offset the cost of the purchase and installation of security cameras/systems on their property, as of January 23, 2024. The grant is one-time funding, up to a maximum of \$500 per residence located within Saddle Hills County, and is only eligible for primary residences. 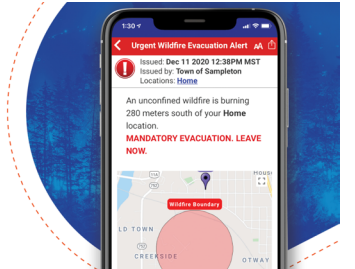

Bids are being received by the Cotillion Butte Recreation Association for the complete removal of the old Cotillion Hall. The original hall was built in 1964 (Part 1), a bathroom was added later (Part 2), along with a new kitchen and meeting room area (Part 3), and a covered back deck (Part 4). Contents include furnace and water system within the hall, as well the stove, oven, and cupboards. Along with the bid to purchase the hall, you must include plans for removal and clean-up. Bidding will be accepted until **March 15, 2024**, and the successful bidder will remove the entire hall prior to **August 1, 2024**. A refundable deposit will be required by the successful bidder and will be returned once the building has been removed and site cleaned up.
