MUNICIPAL DEVELOPMENT PLAN & LAND USE BYLAW REVIEW

Saddle Hills County is conducting a targeted update of its Municipal Development Plan (MDP) and Land Use Bylaw (LUB) to address issues and trends that have emerged since they were last updated, and ensure they are in alignment with changes to the Municipal Government Act (MGA). The updated documents will reflect current community needs and provide Council, Administration, landowners, developers, builders, and the community with renewed confidence in the development process. The draft updates to the MDP and LUB are now ready to share with the public for feedback.

Complete the online survey at saddlehills.ab.ca/MDPLUBupdate, and provide comments that will help us finalize the updates before the MDP and LUB go back to Council for approval. You will have an opportunity to provide feedback to Council in-person at the public hearing, which will be scheduled at a later date.

SADDLE HILLS HEALTH CLINIC

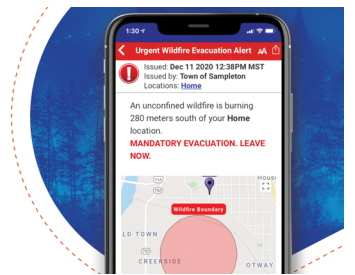
