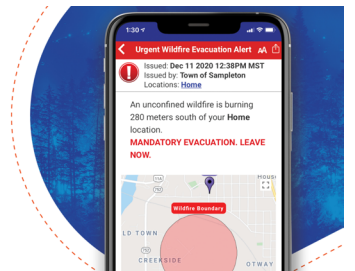
TREE SEEDLING ORDERS OPEN FOR 2025
