DRIVEWAY SNOWPLOW AGREEMENTS

Driveway Snowplow Agreements for seniors and the public are still available for the 2024/25 season. Driveway snowplowing is free if you are disabled or a senior, otherwise fees apply. **Please note, agreements do not roll over and you will need to re-apply each year to be included in the current year's snowplowing.**

REMOTE POTABLE WATER HAULING SUBSIDY RECEIPTS

A reminder to residents eligible for the County's Remote Potable Water Hauling Subsidy in 2024, that the deadline to submit receipts is **January 31, 2025**.

Council has approved two areas for 2025 - Gundy and the area known as Doe River, west of the Pouce Coupe River. Applicants must apply yearly to be included.

A reminder to ratepayers that the final penalty deadline for 2024 property taxes, was **December 31, 2024**. As of January 1, 2025, a 6% penalty has been placed on the total of any outstanding amount. This is in addition to any penalties previously accrued.
