SADDLE HILLS HEALTH CLINIC

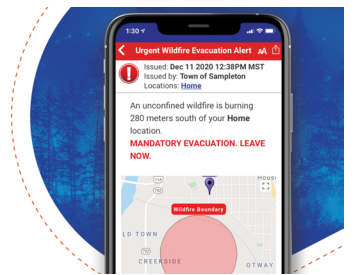
