## DOG LICENCE RENEWALS

If you live in the Hamlet of Woking and have one or more dogs, please note that last year's Dog Licences expired on **December 31, 2024**. ## REMOTE POTABLE WATER HAULING SUBSIDY

The Remote Potable Water Hauling Subsidy has been created to provide a fair and equitable subsidy to Saddle Hills County residences that will not be able to connect to the Rural Potable Waterline. Council has approved two areas for 2025 - Gundy and the area known as Doe River, west of the Pouce Coupe River. Applicants must apply yearly to be included. ## PRIVATELY OWNED EQUIPMENT LIST

Contractors wanting to provide heavy equipment and gravel hauling services for Saddle Hills County, must register with the County annually by completing and submitting a Privately Owned Equipment Registration Form. These forms are available online at [saddlehills.ab.ca/privately-owned-equipment](https://saddlehills.ab.ca/privately-owned-equipment), by scanning the QR code, or at the County Admin Building. You can register at any time, however; our construction season usually begins on, or around, April 1, and we urge interested contractors to submit their applications by **March 15, 2025**.
