## **2024 TAX PENALTY**

A reminder to ratepayers that the final penalty deadline for 2024 property taxes, was **December 31, 2024**. As of January 1, 2025, a 6% penalty has been placed on the total of any outstanding amount. This is in addition to any penalties previously accrued. 


# **RURAL POTABLE WATER PROGRAM**
