# Remote Area Heating Allowance Program

## Propane and Heating Oil

#### 2021-23 Application

#### Eligibility

If you reside outside the franchise boundaries of a natural gas distributor, you may be eligible for a 25 per cent rebate (less the GST and Federal Carbon Tax) on heating oil and/or propane purchases.

If natural gas service extends to your location in the future, your eligibility for heating oil/propane rebates terminates.

#### Rebate payment limit

You will receive a rebate for:

- up to 18,185 litres (4,000 gallons) of propane OR
- up to 12,275 litres (2,700 gallons) of heating oil OR
- a proportionate combination of both for each calendar year (January to December).

These quantities are approximately twice the current annual domestic consumption and intend to allow the full program benefit for all eligible users of these fuels. Rebates are subject to the Rebates Authorization Regulation.

#### Application – Process

Complete and sign the application form and submit it, with your original or a clearly printed copy of invoices/delivery tickets for heating oil and/or propane, to Rural Utilities.

Each invoice/delivery ticket must clearly include the following information:

- Name and address of purchaser
- Date of fuel delivery
- · Amount of fuel purchased
- Unit cost of the fuel per litres
- Total paid (without GST and Federal Carbon Tax)

#### Application – General

The Remote Area Heating Allowance Program expires March 31, 2023.

Applications are accepted until March 31, 2024 for fuel purchases up to and including March 31, 2023.

Invoices dated **one year or less** from the date the Remote Area Heating Allowance Program receives your application are valid.

Should you require your rebate payment via direct deposit, please complete the form and submit to Rural Utilities Office. However, if you currently receive your rebate via direct deposit to your bank, **do not complete** another form **unless** your direct deposit information has changed.
